Bahamas Charter Costs Explained

WHAT IS INCLUDED IN THE COST OF YOUR SKIPPERED CHARTER:

- Sail Canada professionally trained and certified instructors as your charter skippers
- Yacht charter starts from 1700 on the first day of your program until 0900 on the last day of your Charter.
- A one week charter includes 7 nights on the boat.
- Items 1 4 listed below
- Goggles, snorkels & flippers (Sizes S, M, L; i.e. European sizes 36 44)
- PFD's (adult size only)
- Yacht Inventory as described below
- Bahamas Cruising tax, cruising permits, anchoring and mooring fees.

YACHT INVENTORY:

You will be sailing on a luxuriously equipped 2007 Catalina Morgan 440. The yacht includes: dinghy with 15 hp outboard engine, full cruising area charts and cruising guide or pilot book, navigational equipment (binoculars, hand bearing compass and course plotting equipment), water maker (40 gal/hour), generator, inverter, 600 amp hours lithium ion batteries, 1000+ watts of solar power, diesel and gas fuel, cooking gas, VHF radio, autopilot, electric anchor windlass, wind instruments, GPS plotter, liferaft, furling mainsail, furling genoa sail, galley equipment (cooking and eating utensils), standard safety equipment (navigational and first aid), hot water, bed linen, sound system, dodger and bimini for shade. The boat also includes BBQ, cockpit cushions, clothes washer, victron power management system.

ALSO INCLUDED IN YOUR SKIPPERED CHARTER:

1. Provisioning & beverages

Provisioning and beverages (wine & beer) are included in your charter. In December we will be reaching out to discuss food & beverage preferences. Most of the shopping will be done in the USA prior to the boat heading to the Bahamas. Fresh fruit, veggies and such will be purchased in the Bahamas as stock allows. We plan to fish while sailing so if we are lucky there will be fresh fish, lobster, crab and conch.

2. Fuel

Costs associated with diesel for the boat, propane for cooking and gas for the dinghy outboard are included in your skippered charter.

3. Water

Water is included. The boat has a water maker (40 Gal/hour) onboard. This water is safe to drink.

4. Mooring and anchoring fees

In the Bahamas, mooring is generally by anchor, mooring ball or at a marina facility. Mooring ball & marina docking fees are included.
